

America is in a state of moral free-fall, plunging toward self-destruction. In the face of ever-increasing national immorality, the “legalization” by government of many acts which have for centuries been held to be criminal, as well as the rapid erosion of the People’s basic constitutional rights and liberties, where’s the church? John Adams stated, “The church is the moral compass of society.” Tragically, the church for years abdicated that role.

As a result, America has lost her moral bearings. The easiest thing to do is blame heathens. The government demands something in return—the surrender of constitutionally protected rights, like freedom of speech, and even freedom of religion! As Dr. Kennedy asserts, the church has been gagged!

Most churches in America today are incorporated and organized as tax-exempt 501(c)3s, only because attorneys convinced pastors and ministers they needed to. They were tricked into believing they couldn’t function without the legal *blessing* of the State. But there’s at least two sides to every story. Just wait until you hear *the rest of the story!*

In legal contemplation, an incorporated 501(c)3 church is a government-established, government-licensed church. Furthermore, in American jurisprudence, corporations have no constitutionally protected rights! Government licensure is the most effective means ever devised to silence the church; but this is nothing new or unique to America. Political opportunists have, throughout church history, recognized that by conning the church into taking government licenses, the church would then come under their control.

A licensed church is a controlled church. A controlled church is a gagged church. So, what can be done? We must restore the church system established by our forefathers—“free-churches”. To do that, the clergy must become knowledgeable.



Hushmoney is a shorter work, intended as a primer for the busy pastor or minister. It needs to get in the hands of every church and ministry leader!


